# **PRIVACY POLICY**

# 1. INTRODUCTION

By accessing www.hotelpostetzoumaz.com, you may provide us with personal information such as your name and surname (for a physical person), company name (legal person), residential address and domicile address, email address, profession and professional status (employee or independent), your function within your company, your age and sex, as well as the IP address with which you are connected to the internet.

This information and the manner in which it is processed are protected by the Swiss Federal Data Protection Law issued June 19<sup>th</sup>, 1992 and where applicable, by the new European Union General Data Protection Regulation (GDPR) which entered into force on May 25<sup>th</sup> 2018.

This privacy policy aims to ensure that you are aware of the information that we process and to assist you in understanding the manner in which we may use such information.

## 2. PROCESSING YOUR DATA

Only the information that you provide voluntarily to us as a visitor to our site or when you communicate with us in any other manner and for which you expressly provide your consent to processing are collected and processed by us.

You can complete a contact form through our website in which the following information are requested: name, surname and email address.



To facilitate booking rooms or other services, we provide the option of booking online either through reservation platforms or directly on our site. In case of suppliers, you will find link with their privacy policy.

### 3. PURPOSE OF PROCESSING

The personal data that we process is used in connection with our business relationship, or more generally so that we can communicate with you by sending information that may be relevant to you and keep our contact and client list updated.

We do not sell your personal information or make it available to third parties with the exception of subcontractors that we may use for data processing. In collecting some of your personal information, the purpose is an operational purpose to respond to requests and a marketing purpose to send offers.

#### 4. TRANSFER OF INFORMATION

To process your data, as well as for the maintenance and support of our IT systems, we call upon subcontractors (service providers) based in Switzerland and abroad. When our subcontractors' servers are located abroad, we ensure that they are set up in a state where the legislation with regard to data protection is equivalent to the FDPL and the GDPR and that our subcontractors apply organizational and technical measures that comply with both the latter.

### 5. DATA PROTECTION MEASURES

## 5. DURATION OF STORAGE

We will store the data of a personal nature in our systems for as long as is required for the planned processing. When processing is complete, your data is destroyed.

### 7. COOKIES & PLUGINS

Our site uses cookies and plugins which may tend to record data automatically. Using them makes browsing the site more pleasant by improving its ergonomics based on the data collected. This data may also be used for statistical purposes, analyzing the behavior of internet users and geo-localization with the aim of personalizing our sales offer.

When you browse our site, the computer you are using dialogues with a server which provides it with all the required resources by automatically recording every operation in a specific file in which the computer used is identified by its IP address. This is how the browser you use sends us certain standard data, notably about the browser used and its functionalities, the operating system of the computer, tablet or smartphone used, third-party sites (such as Facebook) from which you may have connected as well as the dates and times our site was accessed.
